CORRECTION OF PROTECTIVE COVENANTS

WHEREAS, RANDY FEUCHT CONSTRUCTION, INC., filed, or caused to be filed, certain Protective Covenants in and to certain real property located in Denton County, Texas, described in said Protective Covenants recorded in Volume __, Page __ of the Deed Records of Denton County, Texas; and

WHEREAS, the common area Tract "A" was described in said Protective Covenants referred to above; and

WHEREAS, the legal description by metes and bounds of the common area Tract "A" contained in the Protective Covenants referred to above contain certain erroneous puts and calls which were contained therein by accident;

NOW, THEREFORE, to correct the above mentioned discrepancies the legal description by metes and bounds of the common area tract "A" should read, and hereby is changed to read, as follows:

COMMON AREA TRACT "A"

All that certain tract or parcel of land situated in the S. C. Hiram Survey, Abstract No. 616, Denton County, Texas, and being a part of a certain (called) 1.335 acre tract "B" deeded by V. W. Redman to Randy Feucht Construction, Inc. on the 19th day of March, 1981 recorded in Volume 1066, Page 431, Deed Records of said County, and being more fully described as follows;

BEGINNING at the Southmost Southeast corner of said 1.335 acre tract "B" an iron pin in the North Right-of-Way of Hopkins Drive;

THENCE N 00 degrees 20' 43" W a distance of 174.84 feet to an iron pin;

THENCE S 88 degrees 42' 07" E a distance of 79.81 feet to an iron pin;

THENCE N 00 degrees 03' 06" W a distance of 10.535 feet;

THENCE S 89 degrees 56' 54" W a distance of 22.676 feet;

THENCE N 00 degrees 03' 06" W a distance of 133.67 feet;

THENCE N 89 degrees 56' 54" E a distance of 30.67 feet;

THENCE N 00 degrees 03' 06" W a distance of 18.92 feet;

THENCE S 89 degrees 14' 41" W a distance of 30.67 feet;

THENCE N 88 degrees 22' 27" W a distance of 64.03 feet;

THENCE S 00 degrees 15' 20" E a distance of 20.00 feet;

THENCE N 89 degrees 44' 40" E a distance of 30.67 feet;

THENCE S 89 degrees 44' 40" W a distance of 30.67 feet;

THENCE S 00 degrees 15' 20" E a distance of 10.00 feet

to an iron pin;

THENCE S 89 degrees 44' 40" W a distance of 12.00 feet to an iron pin;


THENCE S 00 degrees 15' 20" E a distance of 124.70 feet to an iron pin;

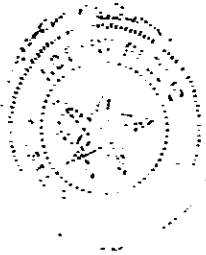
